





Screen Name Redacted 3/03/2023 03:27 PM	If the goal is to encourage pollinator gardens, then be more specific in the permissions within the by-law than to change the height allowed for weeds and grasses. It seems to me that the existing by-law errs in not defining weeds and grasses, and their location/purpose within the lot. Note, the press release uses the word plants, whereas the Clean and Clear By-law uses the word "Weeds" in Section 1.01 (3) (xi). Rather than a blanket removal of weeds and grasses in excess of 8" from the definition of Debris, possibly an exemption should be provided for pollinator-friendly plants and grasses. This would help to clarify which types of plants are permitted to grow to excessive heights, and then keep the criteria which requires other weeds or grasses to be maintained at shorter heights so as to maintain the 'upkeep of their lawns' as noted in the proposed amendment. If pollinator-friendly plants are desired, then the permission should be more specific to the type of plants permitted. Not all weeds and grasses are pollinator-friendly. A listing of appropriate, permitted plants should be included in the by-law. As proposed, there would be no way to enforce maintenance of excessively tall non-pollinator friendly areas/plants or grasses. As proposed, there also seems to be confusion between the statement that removes the 8" height restriction for grasses, but then also requires 'upkeep of lawns'.

There is a fence on the north side of my yard. North of that fence is pasture, east of that fence is a hayfield. My neighbour to the east is almost 10 km away with wetland, woodlots and open abandoned fields in between. Queen Elizabeth II Provincial Park (QEII Park) is less than a km north of me. Much of the road to the west of me is QEII Park, other conserved lands, or private property left wild. And yet my yard had to follow City standards. While the grass could grow much longer than 8 inches just a fence wire width away from my yard, my yard had to be cut to less than 8 inches. It was a ridiculous waste of time on everybody's part. We are losing our insect populations thanks to overgrooming our yards. It's not just our bee populations though they are the poster child for the frightening state of affairs. Many other insects are also pollinators. If we lose our pollinators we lose much of our food supply. As I indicated in question 4, however, it is ecosystem biodiversity that is most important. The pollinators will rebound if we just get rid of the monoculture of nonnative grass which supports little of our native biodiversity. We need to do more than allow people who are interested in getting rid of a fully manicured lawns; we need to actually encourage them to do so.
